To the extent that this Investment Account Agreement conflicts with RPB's Investment Policy Statement, RPB's Investment Policy Statement supersedes this Investment Account Agreement.

3. FEES

In addition to the fund's investment management fee, each account will be charged an annual administrative fee of approximately 18 basis points (0.18%) of the account balance. Note that RPB reserves the right to change the fees at any time in its sole discretion.

4. ACCOUNT INFORMATION

RPB provides investors with access to their accounts through Fidelity NetBenefits®, our recordkeeper's online portal. You can view your account information and download account statements. Your organization will receive one login (user ID) to NetBenefits after we've processed this agreement and deposited your money.
